Terms and conditions

The purpose of this contract is to protect you the customer and Steve Hogg trading as Cosmic Egg Productions.

It is mutually agreed that Cosmic Egg Productions shall supply the services and goods specified in the Wedding Video Booking Form and that the customer shall pay the price agreed.

On signing this contract and receipt of the deposit, Cosmic Egg Productions will reserve the time and date agreed, and will make no other reservations for that date.

Payment

Payment is to be made in three instalments:

- £150 booking fee paid on signing of the booking form.
- 50% of the remainder no later than 14 days before the wedding.
- 50% of the remainder on receipt of the wedding film.

There is no VAT charge.

Payments can be made in the form of cash, cheque, BACS transfer or credit/debit card payments via Paypal (subject to a 3.5% fee for the transactions). In the case of cheques please note that a booking cannot be confirmed until this payment has fully cleared into the Cosmic Egg Productions bank account.

Cancellation by the couple

Should you need to cancel your wedding please contact Cosmic Egg Productions as soon as possible. All monies paid will be refunded.

Cancellation by Cosmic Egg Productions

If for any reason, such as ill health, the wedding video filming cannot be fulfilled by Cosmic Egg Productions, all monies paid will be refunded. Every effort will be made by Cosmic Egg Productions to arrange a replacement videographer through business contacts. Cosmic Egg Productions will not be liable for any further damages.

Equipment malfunction

Cosmic Egg Productions cannot be held responsible for loss of coverage due to equipment malfunction, power failure, defective memory cards or theft of equipment. If filming is prevented due to such occurrences, all monies paid will be refunded. Cosmic Egg Productions will not be liable for any further damages.

Insurance

Cosmic Egg productions has insurance for 2 million pounds public liability cover.

Copyright

Copyright of the wedding video will be owned by the customer once monies are paid in full however Cosmic Egg Productions reserves the right to use any videography or images for future marketing purposes.

Adverse conditions

As the customer you need to be aware that video production requires good levels of lighting and therefore filming in low light conditions such as a dark room, evening and night time scenes can adversely affect video quality. Care will be taken to film your wedding as professionally as possible using professional video equipment. For the ceremony and the wedding breakfast speeches, having the room as bright as possible will improve the video quality.

Similarly, audio recording can pick up unwanted noise such as mobile phones ringing, coughing etc. Care will be taken to record your audio using professional equipment.

Editing

The editing of the video is at the discretion of Cosmic Egg Productions although every effort will be made to incorporate any suggestions by you the customer. The completed video will be delivered to you within 4 weeks of the event. Music that has the appropriate licence will be supplied by Cosmic Egg Productions. If you wish to use your own music choice please be aware of the risk of copyright infringement. This includes incidental background music from the band or DJ recorded during the reception. The use of copyright music will limit your viewing of the video to at home with friends and family, as sharing on social media will infringe copyright.
